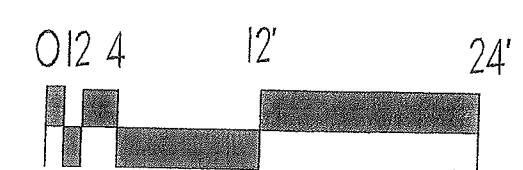

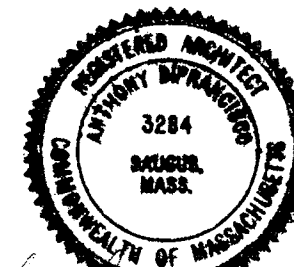
PROPOSED FIRST FLOOR PLAN

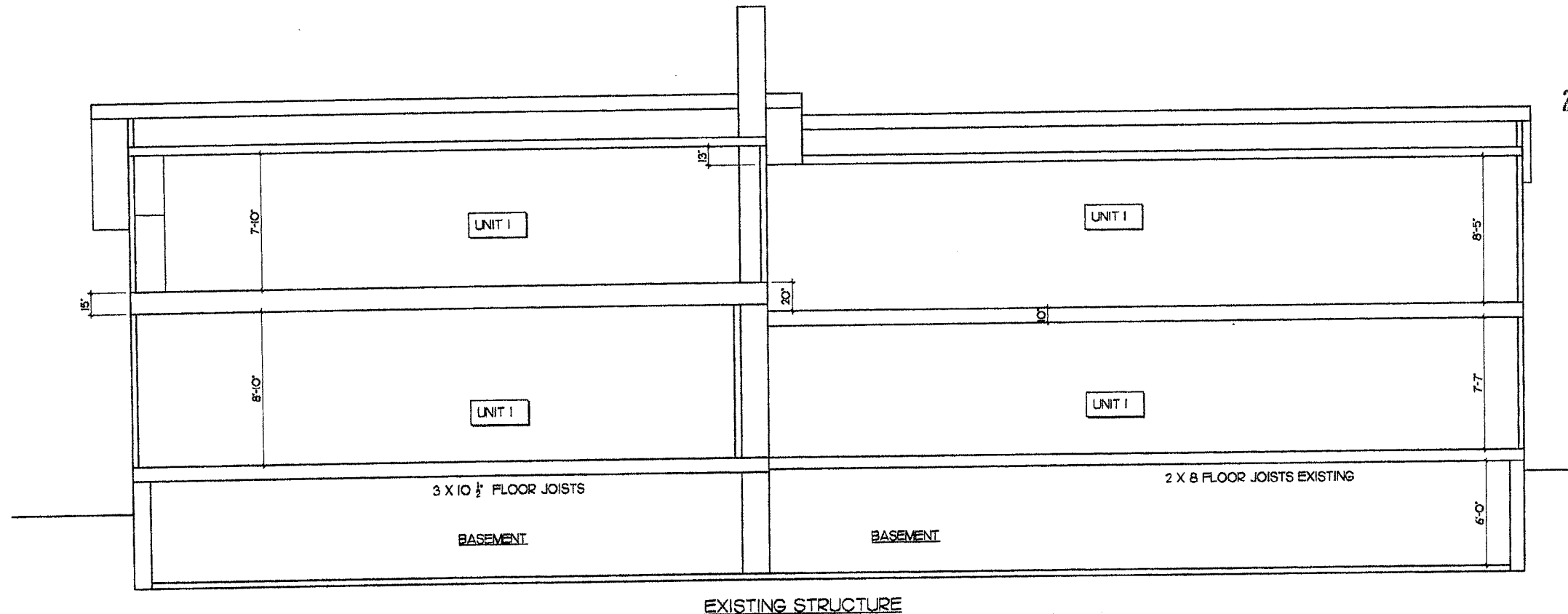
PROPOSED ADDITION SECOND FLOOR PLAN

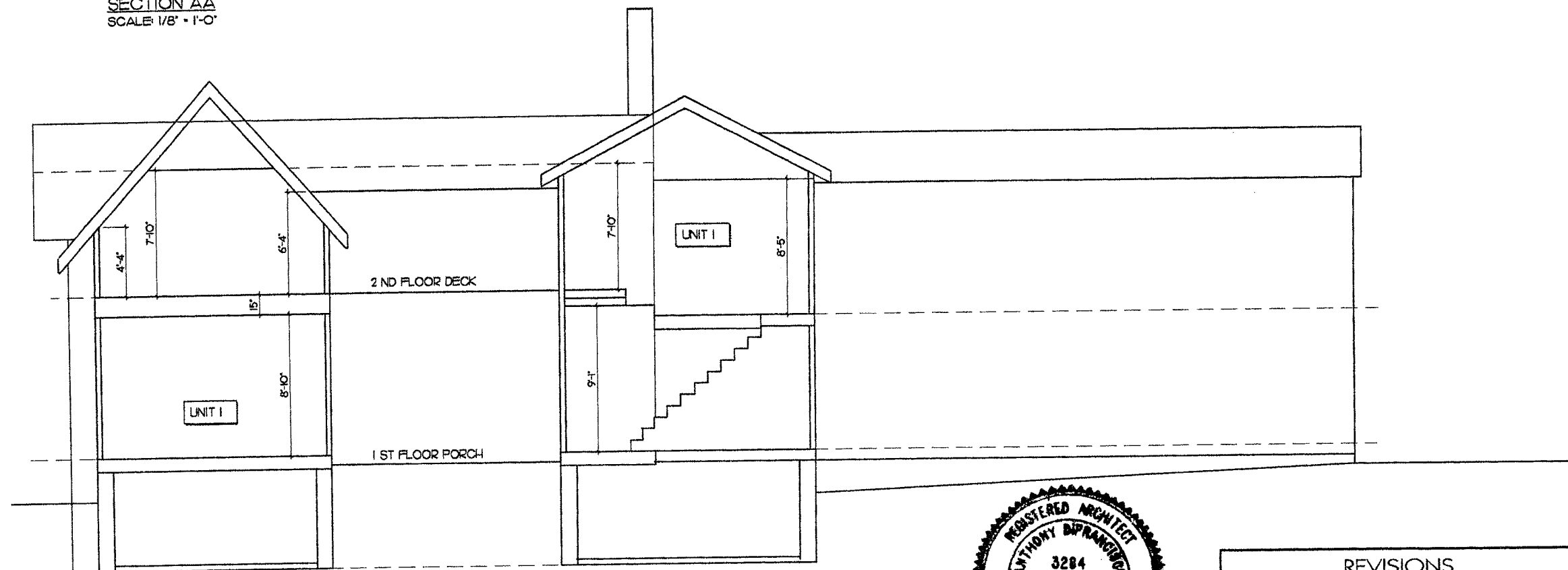

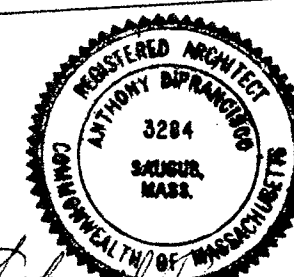


EXISTING STRUCTURE
