On behalf of the Applicant, DW NP Property, LLC (an affiliate of DivcoWest), Beals and Thomas, Inc. respectfully submits this Variance Application in accordance with Section 5.5 -Variances of the Somerville Zoning Ordinance (SZO) for relief from the requirement in Section 6.6.9.D.1.a. that a minimum 60% of ground floor frontage be occupied by active uses for Northpoint Lot JK. The Planning Board previously approved a Neighborhood Development Plan for the NorthPoint development located partially in Somerville and Boston, and mostly in Cambridge. In connection with some updates to the master plan for NorthPoint, the Applicant has submitted to the Planning Board an application for approval of the revised Neighborhood Development Plan. The overall master plan for NorthPoint is included in this Application as part The most significant change to the Neighborhood Development Plan in of Section 4.0. Somerville is to increase the amount of Commercial Office, R&D and/or Laboratory square footage in Somerville from approximately 425,000 square feet to approximately 520,000 square feet. In addition, those Commercial Office, R&D and/or Laboratory buildings in Somerville are the first two buildings the Applicant intends to develop since acquiring the NorthPoint property in the summer of 2015.

Simultaneously with this Variance Application, the Applicant has submitted an Application for Design and Site Plan Review to the Planning Board for development of a Commercial Building on NorthPoint Lot JK. The proposed Commercial Building will be used for a combination of Commercial Office, R&D/Laboratory, and/or Retail and Consumer Services. As the master plan shows, Lot JK is partially in Somerville and partially in Cambridge. The primary front lot line of Lot JK faces North Street and, across the street, Northpoint Common. Pursuant to the SZO, Lot JK has secondary front lot lines on North First Street and Dawes Street. As reflected on the master plan, due to the unique shape and location of Lot JK, although technically a secondary front lot line, Dawes Street is the appropriate location for building services such as loading and, therefore, it is not possible to provide active uses along that frontage. As this Application

describes in more detail, practical difficulty and substantial hardship arise from this condition, which is created by special circumstances applicable to Lot JK, granting the requested Variance is the minimum grant required to permit reasonable use of the building, and granting the requested Variance for Lot JK and will otherwise be in harmony with the general purpose and intent of the SZO.

This fee is the maximum fee required, as the fee, if calculated based on the square footage of the proposed building, would be higher.



Section 2.0 Project Narrative

2.0 PROJECT NARRATIVE

2.1 Introduction

The proposed project is located on a single parcel to be subdivided, Lot JK, which is part of the larger mixed-use NorthPoint development.

Lot JK (the Site) is approximately 62,502 square feet. It is bounded by North Street to the south, North First Street to the west, Dawes Street to the north, and a new park/civic space to the east. The Site is part of the larger NorthPoint development site. The uses proposed on the Site are a combination of Commercial Office, R&D and/or Laboratory, Retail and Consumer Services. The gross square footage of the proposed building is approximately 370,000 square feet.

2.2 Existing Conditions

The Site is currently undeveloped vacant former railroad land. It is one of twenty (20) building parcels in the NorthPoint mixed-use development. To date, condominium buildings on Lot S and Lot T, a rental residential building on Lot N, Northpoint Common, Child Street Park and related infrastructure and other public amenities (including the Brian P. Murphy Memorial Staircase) have been constructed in NorthPoint. The proposed building on Lot JK will be the first commercial building to be constructed in NorthPoint. The surrounding roadway network is currently undergoing preliminary construction preparation. The Site is partially located in the North Point Special District (NPSD). The design of the building and layout of the Site conforms with all requirements of the SZO except as specifically described in this Application.

See the attached Neighborhood Context Plan/Aerial Photograph in Section 4.0.

According to the Massachusetts Cultural Resource Information System (MACRIS) there are no historic resources on or abutting the Site.

2.3 Proposed Conditions

The new Lot JK building is an approximately 370,000 gross square foot Commercial building to be used for a combination of Commercial Office, R&D and/or Laboratory, and Retail and Consumer Services uses. The proposed building will be approximately 143 feet high (as calculated pursuant to the SZO), plus three levels of underground parking containing approximately 348 parking spaces. The Ground Floor includes approximately 15,000 square feet of Retail and Consumer Services, accessed from the street or public area of the building lobby. The Site is located in the middle of NorthPoint and will eventually be surrounded with other commercial and residential uses in the larger mixed-use development. Because of the master planned nature of NorthPoint, the Applicant has a vested interest in ensuring high quality development on all sides of the Site and can control the overall condition in NorthPoint over multiple parcels to create the desired urban streetscape.

As described above and shown on the master plan for NorthPoint, the Site is bounded by North Street to the south, North First Street to the west, Dawes Street to the north, and a new park/civic space to the east. The south side of the Site faces the large NorthPoint Common, a focal point of the entire NorthPoint development, and, therefore, the south facing frontage along North Street has been determined by the Applicant and the Office of Strategic Planning and Community Development to be the primary front lot line for the Site. Under the SZO, all lot lines along a thoroughfare are also considered to be front lot lines; therefore, the lot line along Dawes Street, which would otherwise be considered the rear lot line of the Site, is technically a front lot line. Section 6.9.6.D.1.a of the SZO requires that sixty percent (60%) of the ground floor frontage of a Commercial Building be As reflected on the site plan, the side of the building along occupied by active uses. Dawes Street is, by necessity, the location of the loading and other service areas for the proposed building, as opposed to the lot lines facing NorthPoint Common, a new park/civic space or the major retail corridor on North First Street.

2.4 Variance Request

This Application is a request for a Variance from Section 6.9.6.D.1.a of the SZO for the proposed development of Lot JK as shown on the site plan.

2.5 Conformance with Section 5.5 of the SZO

Pursuant to Section 5.5 of the SZO, the Board of Appeals may grant a Variance for reasons of practical difficulty and substantial hardship, and only where the Board finds that all of the following conditions apply:

1. There are special circumstances relating to soil conditions, shape or topography of land or structures which especially affect such land or structures but not affecting generally the zoning district in which is it located, causing a substantial hardship, financial or otherwise.

The application of Section 6.6.9.D.1.a to Lot JK creates practical difficulty and substantial hardship for the Applicant. The unique shape of the land that comprises Lot JK is that three sides of the Site have frontage on thoroughfares, and the fourth abuts a park/civic space. By definition, building services (including those required by the SZO, such as loading) must be provided for along one of those lot lines. From an urban design perspective, loading and other services are critical elements that need to be accommodated for the functioning of the building lot and the overall master planned development. They should be located and designed to support the walkability of the area and minimize dead zones, particularly away from pedestrian corridors wherever possible.

The side of the Site facing North Street has been designated as the primary front lot line of the Site because it faces Northpoint Common, a focal point of the entire NorthPoint development linking public access across the Site and, in particular, to

NorthPoint Somerville, Massachusetts

civic and open space areas and pedestrian connections. Similarly, the new park/civic space to the east plays an important role in the civic and open space areas available to the public and providing connections across NorthPoint and the surrounding area. North First Street is the retail spine of NorthPoint; it needs to be activated by retail on both of sides of the street along its length in order to be successful. Therefore, building services are appropriately located along the lot line on Dawes Street. Locating such uses on any other side of the Site would adversely impact pedestrian connections to and through Northpoint Common and the new park/civic space, and disrupt the overall NorthPoint master plan.

2. The specific variance as may be granted by the Board is the minimum variance that will grant reasonable relief to the owner, and is necessary for a reasonable use of the building or land.

The Variance requested is the minimum variance from the applicable requirements necessary for reasonable use of the building. As described above, Lot JK is one of twenty (20) building parcels in the NorthPoint master plan. The Applicant has a vested interest in ensuring that the development of each parcel is first class and does not detract from the future development and success of every other parcel in the master planned area. Therefore, although the loading and service areas are proposed to be along Dawes Street to serve Lot JK, they have been designed with architectural details intended to complement the overall façade composition (including materials, bay structure and fenestration) and to maintain a positive pedestrian experience at driveway crossings and via streetscapes and sidewalks, all of which conform to the requirements of the SZO.

We note that all lots in NorthPoint with frontage on Dawes Street are intended to have loading and other building services accessed from Dawes Street. The length of the streetscape and preliminary design guidance for each of those facades has been designed to accommodate those services while at the same time creating an active and attractive urban environment. In addition, we note that, with the exception of the Variance requested in this Application, the proposed development of Lot JK complies in all respects with the SZO, including the requirements for fenestration and breaks in the façade.

3. The granting of the variance will be in harmony with the general purpose and intent of this Ordinance and will not be injurious to the neighborhood or otherwise detrimental to the public welfare. In addition to considering the character and use of the nearby buildings, the Board, in making its findings, shall take into account the number of persons residing or working in such buildings or upon such land, and the present and probably future traffic conditions.

The granting of the requested Variance will be in harmony with the general purpose and intent of the SZO, which is to "establish regulations supporting the

development of a comprehensively planned neighborhood of mixed use, moderateto high-density development within easy walking distance to transit." As described above, we note that the NorthPoint master plan, as approved by the Somerville Planning Board, establishes such a comprehensively planned mixed-use neighborhood with easy access to public transportation. The proposed development of Lot JK is consistent with that approved mixed-use master plan. In addition, we note that, with the exception of the Variance requested in this Application, the proposed development of Lot JK complies in all respects with the SZO, including the requirements for fenestration and breaks in the façade. Due to the master planned nature of NorthPoint and the design of Lot JK, particularly utilizing Dawes Street as the access for the required building services to preserve and encourage the walkability of the NorthPoint site, granting of the requested Variance will be in harmony with the general purpose of the Ordinance and will not be injurious to the neighborhood or otherwise detrimental to the public welfare. We also note that, although a portion of the Site is located in Somerville, all vehicular access to the Site and all of NorthPoint is and will continue to be from Cambridge.




North Elevation - Somerville Facade













South Elevation - Cambridge Facade





Parking Plan - Level 1









The Vertex Companies, Inc. (VERTEX) has prepared this brief summary of the environmental status, environmental reports, and assessments pertaining to the portion of the Northpoint Development Site inclusive of Parcel J/K.

Currently the only active Release Tracking Number (RTN) tracked by the Massachusetts Department of Environmental Protection (MassDEP) pertaining to Parcel J/K is RTN 3-11533. The release listed under RTN 3-11533 is comprised of the linked RTNs 3-12277, 3-26810, 3-29887, and 3-32730, which were closed following linking to RTN 3-11533 and are henceforth managed under the master RTN 3-11533. The linked release listed under RTN 3-11533 is located on portions of the former Boston & Maine (B&M) Railroad Yard currently identified as the Northpoint Development Site located in portions of Cambridge, Somerville, and Boston, Massachusetts (the "Site"), a portion of which includes Parcel J/K.

The linked releases listed under RTN 3-11533 pertains to elevated concentrations of contaminants of concern (COCs) in soil associated with the historical industrial/commercial uses of the Site and the widespread presence of urban fill materials.

A Class C-1 Response Action Outcome (RAO) was submitted for RTN 3-11533/3-12277 on behalf of then owner B&M on July 1, 2005, and a Phase II Comprehensive Site Assessment (CSA), Phase III Remedial Action Plan (RAP), and Class C-2 RAO report (Phase III/Phase III/Class C-2 RAO) was submitted for RTN 3-26810 on behalf of CJUF on September 26, 2012.

RTN 3-26810 was linked to RTN 3-11533 on June 1, 2015 in a Post-Temporary Solution Status Report, 5-Year Periodic Review, & Request to Link Release Tracking Numbers report.













Following linking, Master Site RTN 3-11533 is managed by current Site owner DW NP Property, LLC (DW) under a single Temporary Solution. DW is an Eligible Person for RTN 3-11533 per Massachusetts General Laws (M.G.L) chapter (c.) 21E.

Details regarding the regulatory status and environmental investigations conducted to date on the portion of the Site currently referred to as Parcel J/K are included in various site-wide reports prepared from 1995 through the date of this letter, as listed below.
