# IFB 17-17 Excavation and Backfill of Contaminated Soil 10 POPLAR STREET

**Site:** Vacant Property

10 Poplar Street Somerville, MA

**RE:** Excavation, transportation and disposal of lead and petroleum hydrocarbon impacted soil

The City of Somerville, Massachusetts is requesting pricing from qualified contractors to perform the Scope of Work outlined below. This work will be performed under the direction of a Massachusetts Licensed Site Professional (LSP) already engaged for the project and in accordance with the provisions of the Massachusetts Contingency Plan (310 CMR 40.0000).

#### Scope of Work

A historical release and/or the presence of historical urban fill material has resulted in the presence of metals and petroleum hydrocarbons at the property located at 10 Poplar Street in Somerville, Massachusetts (here-in-after referred to as the "Site"). A Site Locus Map is provided as Figure 1. The objective of the proposed remedial activity is to excavate soil impacted with lead and polycyclic aromatic hydrocarbons (PAHs) at elevated concentrations in several areas of the Site to depths up to 3 feet (ft) below ground surface (bgs). The locations of the areas to be excavated are detailed on the Site Plan, which is provided as Figure 2. It is estimated that a maximum of 450 cubic yards (yds³) of impacted soil will be excavated and stockpiled on-site for subsequent loading, transportation and disposal of the soil at a licensed disposal facility. For estimating purposes, it is also assumed that all impacted soil generated as a result of the excavation activities detailed herein will be characterized as non-hazardous waste. Should the impacted soil be characterized as hazardous waste, a change order must be provided to the City of Somerville prior to the transportation/disposal of the impacted soil.

#### **GENERAL**

The Contractor's responsibilities include, but are not limited to, the following:

- 1. Contractor shall provide sanitary facilities for the use of the Contractor's employees, the Owner/Owner's representatives, and others, as may be necessary to comply with the requirements and regulations of the Department of Health, OSHA, or bodies having jurisdiction. The Contractor shall provide facilities for personnel decontamination and an equipment decontamination pad, if deemed necessary. The Owner assumes no responsibility for the Contractor's Temporary Facilities at the Project Site.
- 2. The Contractor shall provide appropriate containers for the consolidation of normal, non-contaminated solid waste (*e.g.*, trash, daily debris, used personal protective equipment, etc.). The Contractor shall be solely responsible for the proper off-site disposal of all non-contaminated solid waste.
- 3. The Contractor is expected to supply the following materials:
  - Material required for clean backfill from an approved off-site source and hauled to the Site. This will be an optional work for this project and a quotation should be provided separately.
  - All required safety equipment/barricades, and soil stockpiling liners/covers/berms.

- All required Personal Protective Equipment (PPE) as required by the contractor's Site Specific Health and Safety Plan (HASP).
- All materials, equipment, personnel, and incidentals required to excavate, remove, stockpile, load, transport, and dispose of the impacted soil and any related material that is excavated (*i.e.*, asphalt, concrete, etc.). Asphalt pavement and concrete that is generated will need to be disposed of separately from the impacted soil. Contractor should be aware of this and ensure that these materials are segregated on-site and disposed of separately. The cost estimate provided by contractor should include costs associated separate disposal of these materials.
- 4. Locate all utility lines prior to construction, including notifying DIGSAFE. The Contractor shall be responsible for obtaining and maintaining utility clearance from all utility companies, including local water and sewer authorities, for the duration of the project.
- 5. Work can only be performed during the time of 7:00 AM to 4:00 PM, Monday through Friday.
- 6. Obtain all appropriate and necessary federal, state, local, and construction permits.
- 7. Obtain all local, state, and federal permits required for the transportation and disposal of all lead and PAH impacted soil and related impacted media resulting from the performance of this work, excluding Bills of Lading, which will be prepared by the LSP for the project.
- 8. Contractor will be responsible for coordination of their work and scheduling of all transportation and disposal of the impacted soil and related media at the approved disposal facility. The LSP shall approve the disposal facility for impacted soil generated during the performance of this work. Debris, such as concrete, asphalt pavement, or other demolition type debris observed during the performance of the work must be segregated and properly transported and disposed off-site separately from the impacted soil.
- 9. Provide a copy of all permits and completed shipping manifests to the LSP and the City of Somerville.
- 10. Dispose of all remedial excavation-related wastes as designated herein and including but not limited to lead and PAH impacted soil and related impacted or non-impacted media, in accordance with all applicable regulations at the approved off-site facility.
- 11. Determination of the limits of excavation shall be subject to the approval of the LSP and/or his designated representative.
- 12. Determination of completion of the remedial activities shall be subject to the approval of the LSP.
- 13. Determination of clean versus contaminated soil shall be subject to the approval of the LSP.
- 14. Prior to ending operations on any working day or at any time the Contractor is not on-site, the Contractor shall secure all areas of work in a safe manner to the satisfaction of the City of Somerville and the LSP's on-site representative.
- 15. Provide and maintain an adequate supply of all appropriate and required safety equipment in close proximity to all excavation and backfilling activities.
- 16. Contractor shall take reasonable precautions to prevent erosion and deposition of sediments resulting from construction activities. Contractor shall ensure cleanliness of all catch basins within and proximal to the construction area. Catch basins and/or drainage swales shall be protected with hay bales and silt stacks during the construction period, as required.
- 17. Trucks and vehicles leaving the property shall be clean to avoid tracking of material onto public roadways. If public ways becomes impacted with debris, it is the Contractor's responsibility to remediate.
- 18. Contractor shall have spill containment and recovery equipment available at the Site and be prepared to effectively deal with a spill of diesel fuel, gasoline or hydraulic oil from equipment.
- 19. Removal, segregation, loading, transport, and disposal of bituminous asphalt/concrete.
- 20. Backfilling and compaction of the excavation. Subsequent to backfill and compaction, the excavated area. Following backfill specification for optional pricing shall be used:

#### **Structural Fill**

Structural Fill shall consist of clean Sand and Gravel, free of organic material or other objectionable materials and shall be well-graded within the following limits:

Sieve Size	Finer Percent by Weight
3-in	100
No.4	30-90
No. 40	10-50
No. 200	0-8

Structural Fill should be placed within a close range (plus or minus 2 percent) of the laboratory determined (ASTM D 1557) Optimum Moisture Content and compacted to 95% of the maximum dry density as determined by ASTM D1557.

21. Contractor shall provide cost estimate associated with mobilizing equipment and personnel to the Site and completing soil excavation activities. Additionally, contractor shall provide cost estimate associated with returning to the Site to load stockpiled soil onto trucks for off-site disposal. All stockpiled soil must remain stockpiled on and covered with polyethylene sheeting or equivalent and secured on-site until such time that it is loaded/transported off-site for disposal in order to prevent runoff and/or dust generation. Contractor shall also estimate number of days of excavation/soil loading are anticipated as well as provide unit costs for all labor, materials and equipment.

#### \* Pricing Page Base Bid Amount:

Excavation, Transportation and Disposal of lead and PAH impacted soil. It is assumed that soil excavation activities will take three days to complete, load out of impacted soil will take one day to complete and the total soil excavation volume is estimated to be approximately 450 cubic yards.

The unit prices shall represent the exact net amount per unit to be paid the Contractor (in the case of addition or increase) or to be refunded the City (in the case of decrease). Contractually noted adjustments will be allowed for overhead, profit, insurance or other direct or indirect expenses of the Contractor or Subcontractors.

The unit prices shall include cost of fuel, all labor, materials, equipment, overhead, profit, insurance, etc. to cover the finished work of the several kinds called for. Changes shall be processed in accordance with the provisions of the General Conditions governing changes in the work.
