# **Question from Prospective Bidders**

# 1. Aeration and Watering Specification

According to the current specs, the perforated (flexible?) PVC pipe goes around the outside of the of the root ball, attached (with a T fitting?) going upwards toward the soil line? The perpendicular tube is of the same material but separated by filter fabric and filled with 3/4" gravel and fitted with a grate. Will the City accept alternative variations of the irrigation system, for example some of the following products on the market?
