Bidder's Questions

Monday, February 25, 2013

1. *When are the substitution forms due?*

Substitution forms are due with the Bid, February 27, 2013.

2. *For the Vegas Office (D-05), should the square edge EH or the 1" flat knife edge H1X be specified?*

The square edge (EH).

3. *The Enclave Linx (CH-16), should the units shown in the photo, using the inside wedge, be specified or an outside wedge?*

"Inside" Wedge, to create a "C" shape, should be specified.

4. *Are the floors carpeted or hard for the Enclave Linx? For use of casters or glides.*

In the Library, the Enclave Linx will be on Cork flooring.

5. *In the Bid, there are two dates for delivery. ITB states between June and July 2013, whereas on Page 100-4, Article 19 (C) states items must be available for delivery no later than August 16, 2013. Please confirm.*

June through July 2013 is the scheduled delivery date. However, scheduling is subject to change (on General Contractors work completion) making August 16, 2013 the absolute last day at which items may be delivered.

6. *Are the bid sheets available in an excel file that can be emailed?*

Yes, please email the architect to request it.

Please do not convert the PDF from the Bid Set into an excel file.

7. *LT-01 is item number DSW-DD4 (K-Log). This is not a complete item number.*

LT-01, Lab table is DSW-DD4 in the K-Log catalog, and the resin top is preferred. The complete item number is DSW-PDD4.

8. *Article 19, (G) notes that CAL 133 stickers are required for the required furnishings. Is CAL 133 or CAL 117 required for upholstered goods?*

CAL 133 is required for all upholstered goods.

9. *Chairs need to be CAL 133. Do burn certificates need to be provided for all chairs?*

All chairs require a CAL 133 sticker. No burn certificates are required, but can be submitted to the City of Somerville Fire Department, if preferred.

10. *Section 100 sheet has a delivery line at the end, should delivery and install costs be rolled into the unit price of each item, or provide one total for install?*

Bidders should include installation and delivery costs in each line items' unit cost.

On the 'Section 100' sheet, the 'Lump Sum' price would be the total bid cost.

11. *Item FC-01 for the 36 each Mobile pedestals calls for a height of 24". Our pedestals are 26-7/8" high. Is this ok to quote or is there a height constraint for the mobile pedestals?*

The height constraint would be at 28" high for any mobile pedestal.
