The seating model number should be 90.12.86.4.

3. The named fabric, Maharam/Synergism, is not found. Please advise what pattern in Maharam is wanted?

The Auditorium seating should comply with the following – Mill: Maharam Pattern: Messenger Color: Ultramarine Grade: S, or approved equal.

4. The specification calls for floor and riser mounted seats, is the balcony to be riser mounted?

All seating will be floor mounted. There is no riser mounted seating in the Auditorium.

5. The specification does not call for CA 133 treatment and labeling, is it required?

Yes, the seating for the auditorium shall comply to CA 133 regulations.

6. Could you please confirm that we would be bidding to a general contractor?
