Questions

1. Does the General Contractor or the Electrical Contractor carry the electrical and wiring work for the Audio Visual scope? Is the demolition of these items included in the Electrical spec or in the General Contractors?

Electrical contractor will own the Audio Visual scope of work, AV is part of 260000 Sub bid. Electrical contractor will disconnect power on devices and equipment and the removal of items will fall under the General Contractor's scope of work.

2. Where can the contractor park and where can dumpsters be placed?

All parking and dumpster placement will be coordinated with the School Department and City (Capital Projects Manager for the project).

3. How will CORI checks be conducted?

All personnel of the contractor will fill out a CORI form provided by the school department and then returned to the school department who will conduct the CORI checks.

4. Under the remediation specification section, what is the intent for the negative air? Will it be required for the duration of the project or for the demolition portion only?

Negative air is required throughout the demolition process but is not necessary during the construction phase.

5. What are the hours for contractors? When can they be on site?

Contractors are to coordinate hours with the City of Somerville (Capital Projects) and the School Department. If contractors would like to work weekends or double shifts that is an option, it just needs to be coordinated.

6. On HD203 and ED203, are the fans for demo by both trades? What is an "Existing Destrat. Fan"?

The ceiling fans will be removed by the HVAC contractor. The electrical contractor will be responsible for disconnecting the power source from the ceiling fans. Remove the wiring and make the electrical circuit safe for the equipment removal. "destratification fan" is another name for a ceiling fan.

7. There are no instructions or bid forms for the sub bidders for this project. All language pertains to the G.C., ie."must be DCAMM certified in General Construction" (that is not a category for subs.)

The sub-bid forms and language is included in the addendum and can be found in attachment A, specification section 003000.

8. The invitation to bid page 000200-1 states "Filed Sub-bids, No filed sub-bids are required on this project." However on the index page and in section 230000 states "filed sub-bid required," please confirm that HVAC will be bidding as a filed sub-bid.

The line in section 000200-1 is being called for removal in this addendum and 003000 SUB BID FORM and a revised 003050 GENERAL BID FORM are attached as items A and B in this addendum. HVAC is a filed sub-bid.

9. The auditorium shows an Exit Sign type EW1B which is not on the fixture schedule. Is it included in the bid?

EW1B on drawings E202 and E203 should be EW1A Exit Sign tags.

10. Spec Section 26000 2.12 A. 7 says the fire alarm shall be EST. On E401 it is shown that although there is an existing EST panel, all of this contract work comes out of an existing Simplex panel. Could you clarify?

Provide a new voice evacuation fire alarm control panel with interface to the existing Simplex 4100 panel as illustrated on drawing E401.

E401 states that all fire alarm final connections shall be by the owner's fire alarm maintenance contractor. Can you supply contact information?

This will have to be coordinated with the City of Somerville and the awarded General Contractor

11. The General Bid Form in section 003050 does not have a section to list the filed sub bids. See Chapter 149 44E, Paragraph M of the bid form also states a final completion date of March 14, 2014. Will a new General Bid Form be issued?

A new General Bid Form has been issued. Please see attachment B

12. Will a Sub Bid Form also be issued that follows Chapter 149 44F?

A Sub Bid Form has been issued. Please see attachment A.

13. The electrical filed Sub Bid Section 260000 Paragraph D.1.a Lists Telecommunication 270000, Security 280000 and Audiovisual 274000 and requires each sub-bidder to list in Paragraph E of the "Form for Sub Bids" the name and bid price. There are no Telecommunication 270000 or Security 280000 sections. Will these sections be issued or will the reference to these sections in Paragraph D.1.a be deleted?

Sections 270000 and 280000 should be removed from this list. 274000 and 265561 should be on the list because they are filed sub bids as a part of 260000.

14. The specification includes Section 265561 for Theatrical Lighting and Control Systems. Will this section be included as part of Electrical Filed Sub Bid Section 260000.

Yes, section 265561 is apart or the Electrical Filed Sub Bid.

15. The Responsible Employer Ordinance of the City of Somerville calls for the sub contractors and general contractors to have Apprenticeship Program, do we need to provide a Sponsor Verification form with our bids?
