Questions

1. In Addendum #2 it is instructed that the General Contractor carry allowances in their bids for four of the Filed Sub-Bids, when are these going to be re-bid? Additionally, does the project schedule change since these will most likely be re-bid after the Notice to Proceed?

The General Contractor bid due date has shifted to allow one week for General Contractors to obtain bids for the four filed sub-bid trades that were not bid on. General Contractors shall include the sub-trade amount in their total proposed contract price. General Contractors are not required to break down the costs of the sub trades but must submit the names of proposed subtrade contractors to the awarding authority for written approval. If the awarding authority determines that any sub-contractor is not qualified or responsible the general contractor must obtain one that the awarding authority approves of at no additional cost to the owner.
