# I. General Information and Bid Submission Requirements

# **Bid Delivery**

All bids must be delivered to City of Somerville, Purchasing Department, 93 Highland Avenue, Somerville, MA 02143.

Bids must be delivered by 11:00 A.M. on Monday, May 28, 2013.

1 copy of the bid should be submitted. Bids must be sealed and marked as follows: Bid for "Ford Vehicles, Bid No. 13-76".

All bids must include a non-collusion form, tax compliance certificate, bid pricing sheet, and reference form as provided in this IFB.

# Bid Signature

A bid must be signed as follows: 1) if the bidder is an individual, by her/him personally; 2) if the bidder is a partnership, by the name of the partnership, followed by the signature of each general partner; and 3) if the bidder is a corporation, by the authorized officer, whose signature must be attested to by the clerk/secretary of the corporation, and with the corporate seal affixed.

# Time for Bid Acceptance

# Modification or Withdrawal of Bids, Mistakes, and Minor Informalities

A bidder may correct, modify, or withdraw a bid by written notice received by the City of Somerville prior to the time and date set for the bid opening. Bid modifications must be submitted in a sealed envelope clearly labeled "Modification No.\_\_" to the address listed in part one of this section. Each modification must be numbered in sequence, and must reference the original IFB.

After the bid opening, a bidder may not change any provision of the bid in a manner prejudicial to the interests of the City or fair competition. Minor informalities will be waived or the bidder will be allowed to correct them. If a mistake and the intended bid are clearly evident on the face of the bid document, the mistake will be corrected to reflect the intended correct bid, and the bidder will be notified in writing; the bidder may not withdraw the bid. A bidder may withdraw a bid if a mistake is clearly evident on the face of the bid document, but the intended correct bid is not similarly evident.

# Right to Cancel/Reject Bids

The City of Somerville may cancel this IFB, or reject in whole or in part any and all bids, if the City determines that cancellation or rejection serves the best interests of the City.

# Bid Prices to Remain Firm

All bid prices submitted in response to this IFB must remain firm for 60 days following the bid opening.

# **Unbalanced Bids**

The City reserves the right to reject unbalanced, front-loaded and conditional bids.

# Unforeseen Office Closure

If, at the time of the scheduled bid opening, Purchasing Department is closed due to uncontrolled events such as fire, snow, ice, wind, or building evacuation, the bid opening will be postponed until 2:00 p.m. on the next normal business day. Bids will be accepted until that date and time.

# II. Purchase Description/Scope of Services

# Contract Term Length and Renewal Options

The contract will remain in effect from <u>June 1, 2013 through May 31, 2013</u>. The City reserves the right to award contracts to more than one vendor based on the lowest price for each item bid.

# Contract Value

The City of Somerville, Department of Public Works, estimates the bid value to be \$500,000.00 for the Ten Vehicles. This is just an estimate.

# Price Submission

All prices must contain a unit rate, if applicable and a total contract price as requested on the bid price form in this IFB.

# **Estimated Quantities**

The City of Somerville has provided estimated quantities for item over the course of the next three years. These estimates are estimates only and not guaranteed.

### Brand Name "Or Equal"

Any references to any brand name or proprietary product in the specifications shall require the acceptance of an equal or better brand. Samples may be requested before a final decision is made. The City has the right to make the final determination as to whether an alternate brand is equal to the brand specified.

# Warranty

The bidder shall specify and guarantee the standard warranty on the vehicles, within the bid document.

The bidder warrants that (1) the Supplies sold are merchantable, (2) that they are fit for the purpose for which they are being purchased, (3) that they are absent any latent defects and (4) that they are in conformity with any sample which may have been presented to the City.

The bidder guarantees that upon inspection, any defective or inferior Supplies shall be replaced without additional cost to the City. The Vendor will assume any additional cost accrued by the City due to the defective or inferior Supplies.

# Performance Standards

The vendor selected must be a certified Ford dealer, or a certified dealer of an equivalent brand.

Any vehicle up-fittings for after-market accessories must be completed by an authorized factory installer for the specific equipment. For example: regarding the Fisher Plows and Easterner Dump Bodies its recommended you should use J.C. Madigan in up-fitting the hydraulics and dump bodies.

All electrical wiring shall be continuous with no splices to insure a reliable installation. The wiring and connections will also be weather resistant and neatly tied in place to protect them from abrasion, corrosion and other damage. All warning / emergency lighting shall be on separate circuit breakers supplied by wiring capable of handling at least 125% of the total load that each unit will draw. Plow joy stick controls should be fastened in an area as not to obstruct the safe operation of the vehicle. Attaching the joy stick to the face of the dashboard with Velcro is not acceptable.

The City may reject Bid's from vendors that are (in the City's opinion and best interest) not located within a reasonable traveling distance of our facility. The City may also require onsite service or flatbed towing to and from the vendors location (at the vendor's expense) for any defects, repairs, service of aftermarket accessories during the warranty period.

# **Delivery Terms**

All vehicles must be delivered in a timely fashion after receiving the vehicle order, and be in agreement with the DPW, Superintendent of Highways.

All prices must be F.O.B. Somerville, freight prepaid.

# Description of Services

# Invoicing

Vendor will mail an invoice to the ordering department after completion and delivery of the order.

# Cancellation

The City reserves the right to cancel this contract at any time on any grounds, including the vendor's failure to comply with the specifications provided herein.

# Laws and Regulations

The Bidding procedures shall be in accordance with M.G.L. c. 30B, as most recently amended and all other applicable laws. The contractor shall comply with all Federal, State and Local laws regulations and ordinances governing this type of work.

#### ATR -41-I SIGNALIER

This section describes each of the ATR-41-I major (standard) components.

PLATFORM – 42" X 66" Aluminum Platform with 24" door. Constructed of 1 ½" aluminum pipe schedule 40 bent at 6" radius for corner strength. Floor is aluminum diamond plate 3/16" with 4" kick plate. Mounting Plate to Rotation Motor using 12 Bolts Grade 8 with Torque Strips. Mounting Plate to be made of Core Ten 1/2" thick. Wide Bracket Mounting on Platform offset mounting on Platform for Stability in operations, 2 Braces on side of Boom Tip Pin to support side movement of Platform. Continuous upper rails on Platform, 30" door for access to Platform. Rubber Bumper mounted to Platform.

PERSONNEL RESTRAINT SYSTEM – (2) safety belts or harnesses and lanyards are provided. The anchors for the lanyards are attached to the upper platform support.

INDIVIDUAL LOWER CONTROLS — Individual full-pressured controls at the turret actuate all boom functions. An emergency stop and a tool selector control are located at the upper controls. The lower control station is equipped with a selector valve to override the upper controls. Lower controls are internally mounted in turret for protection.

SINGLE STICK UPPER CONTROL – The full-pressure single-stick upper control includes a safety trigger to prevent inadvertent operation. The lift movements correspond with control handle movements.

HYDRAULIC PLATFORM ROTATOR – A hydraulic platform rotator model HELAC L10-5.5-E-RF180S10H, operated by a control lever, rotates the platform 180 degrees from one side of the outer/inner boom assembly, across the end-hung position, to the other side of the outer/inner boom assembly.

HYDRAULIC PLATFORM LEVELING — All leveling arms must be internal of Boom/NOT OUTSIDE. A master and slave cylinder controls platform leveling. The leveling system can be operated from the upper controls to adjust platform leveling, tilt the platform.

OUTER/INNER BOOM ASSEMBLY – Compensation links must be located inside the boom for protection. The outer/inner boom assembly includes an outer boom, telescopic inner boom, extension system, and hose assemblies. The outer boom consists of an 8 in. x 10 in. (203 mm x 254 mm) rectangular steel section and a 9 in. x 11 in. (229 mm x 279 mm) fiberglass section (Electrogard) to maintain a 38 in. (0.97 m) insulation gap with the inner boom is fully retracted. The 6-7/8 in. x 8-7/8 in. (165 mm x 216 mm) rectangular fiberglass inner boom is housed within the outer boom. The inner boom can be easily removed and disassembled for service and inspection. The extension system consists of a hydraulic cylinder, two integral holding valves, and dual #50 roller chains housed entirely within the boom assembly. The hoses routed through the outer/inner boom assembly are fully contained within the boom assembly. Main boom strapped for extra strength to prevent bell mouth in long term use with 1/2" x 2" weld to boom. The outer/inner boom assembly articulates from 25 degrees below horizontal to 85 degrees above horizontal. Actuated by a double acting cylinder that has two, integral holding valves, the outer/inner boom assembly is offset to one side to provide easy access to the platform. A boom support cradle and a boom tie down strap are included.

LOWER BOOM – Compensation links must be located inside the boom for protection. Each end of a high strength fiberglass insert (chassis insulating system) is installed over a rectangular 8 in. x 10 in. (203 mm x 254 mm) high strength steel section. The steel maintains the 12 in. (305 mm) insulation gap in all the boom positions. The double acting cylinder, with an integral holding valve, allows the lower boom to articulate from horizontal to 80 degrees above horizontal. The lower boom encloses a parallelogram linkage to maintain the knuckle at a constant angle to the turret.

CYLINDERS – Both the upper and lower cylinders are a threaded head-cap design. The upper cylinder is equipped with two integral holding valves that prevent down creep and to lock the booms in position in the event of hose failure. The lower cylinder is equipped with one integral holding valve.

TURRET – The turret wings are designed for strength and rigidity. The bearing cover is continuously welded to seal out moisture and prevent foreign materials from obstructing the turret rotation. The turret plate is machined to provide a flat surface to support the rotation bearing.

CONTINUOUS ROTATION — Unrestricted rotation is accomplished by a hydraulically driven worm and spur gear with a shear ball rotation bearing. The critical bolts holding the lift to the rotation bearing and the rotation bearing to the pedestal are hex head cap screws. These critical bolts are torque seal marked to provide a quick means of detecting any turning of the bolt upon inspection. The eccentric ring backlash adjustment (gearbox pinion adjustment) is described in the "Adjustment" Section of the Service Manual. Also refer to drawing in the "Adjustment" section to set gear backlash.

LUBRICATION – Non-lube bearings are used at most points of motion. The rotation bearing and extension chain require periodic lubrication.

PEDESTAL – The pedestal is tubular with reinforced mounting plate. The top plate of the pedestal is 1-1/4 in. (32 mm) thick and machined flat to support the rotation bearing.

HYDRAULIC OIL RESERVOIR – A 17 gallon (64.41) hydraulic oil reservoir is built integral to the pedestal. The reservoir includes anti-splash baffles and two sight gauges for quick hydraulic fluid level checks.

HYDRAULIC SYSTEM — The open-center hydraulic operates at 2700 psi (176 kg/cm2) at 6 gpm (22.7 lpm). A 10-micron return line filter, mounted above the hydraulic oil level and inside the pedestal, can be easily changed without draining the reservoir. The 100 mesh (149 micron) suction strainer in the reservoir can be removed for cleaning. A gate valve, located below the reservoir, prevents oil loss when the pump is serviced. A magnetic drain plug attracts metal particles from the oil.

PAINT – The complete unit is primed and painted TO MATCH (GEM GREEN) CAB COLOR prior to assembly.

HOSES AND FITTINGS – The hoses routed through the booms are high pressure and nonconductive with swaged hose end fittings. Retainers separate the hoses inside the booms to prevent chafing and nylon sleeves are installed over hoses at points of movement. Reusable fittings can be installed if a hose is damaged.

MASTER CONTROL – The master control energizes the upper and lower control circuits, including engine start/stop and optional two-speed throttle control.

ENGINE START/STOP – The start/stop circuit has been designed so the lift cannot be operated unless the truck ignition switch is in the "RUN" position and the master control is activated. This feature makes it difficult for unauthorized individuals to operate the lift when the truck is locked. An air cylinder at the upper controls and a toggle switch at the pedestal energize this system.

HYDRAULIC TOOL CIRCUIT AT THE PLATFORM – This system uses open center hydraulic tools. The tool circuit provides 6 gpm at 2700 psi.

ELECTRICAL INSULATION SPECIFICATIONS – The outer/inner boom assembly is tested and certified for electrical work at 46 KV and below in accordance with ANSI A92.2 – 1990 requirements. The wiring and connections will also be weather resistant and neatly tied in place to protect them from abrasion, corrosion and other damage. All warning / emergency lighting shall be on separate circuit breakers supplied by wiring capable of handling at least 125% of the total load that each unit will draw.

The City may reject bids from vendors that are (in the city's opinion and best interest) not located within a reasonable travelling distance of our facility. The City may also require onsite service or flatbed towing to and from the vendors location (at the vendors expense) for any defects, repairs, service of aftermarket accessories during the warranty period.

INSTALLATION: Entire assembly including aerial device shall be fully operational when delivered to the City. Any item not specifically mentioned but necessary for a complete assembly shall be included.

Factory authorized Vendor must provide safety, operation and maintenance training at time of delivery. Vendor must also include operator's manuals, service manuals, including but not limited to wiring diagrams and schematics for all aftermarket equipment and or custom fabrications.

WHEREAS, the Vendor was found to be the lowest responsive and responsible Vendor (See <u>Appendix B – Proposal Page</u> attached and made a part hereto); and NOW THEREFORE, the City and the Vendor in consideration of mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, agree as follows:

#### ARTICLE I. VENDOR'S SERVICES/SUPPLIES

The Vendor shall provide the Services and/or Supplies described in <u>Appendix C</u>, Scope of Services/Specifications, attached and made part hereof.

#### ARTICLE II. TERM AND/OR DELIVERY

#### A. Term.

- 1. The term of this Contract shall commence on the day and year first written above.
- 2. The Vendor shall complete the Services and/or furnish the supplies, by

  (the" Completion Date"). If this Contract is for Supplies, the

  Vendor agrees to deliver the Supplies upon receipt of an approved Purchase

  Order.
- 3. The term of this Contract may be extended at the sole discretion of the City, through written notice to the Vendor.

#### B. Delivery (Applicable to Supplies Only).

- 1. The Supplies are to be delivered F.O.B. to:
- 2. If this Contract is for Supplies, the City may at its sole discretion amend this Contract for a maximum of twenty five percent (25%) of the original Contract amount in the event that the awarding authority finds that it is in the best interests of the City. Any additional Supplies must be billed at the same unit price as the original proposal. (Quoted or Non-Exempt Sole Source Agreements may not exceed \$24,999, including amendments and extensions).

#### **ARTICLE III. PRICE AND/OR COMPENSATION**

#### A. Price (Applicable To Supplies Only).

- 1. In case of an error in extension prices quoted herein, the unit price will govern.
- 2. The Supplies and the unit price for the Supplies are listed in **Appendix B**, attached and made a part hereto.

#### B. Payments.

1. During the initial term of this Contract, the City agrees to pay the Vendor a total not to exceed \$\_\_\_\_\_ for Services rendered and/or Supplies received as specified in **Appendix C**.

- 2. The City reserves the right to increase the quantity of Services and or Supplies in accordance with G.L. c. 30B.
- 3. The City shall make no payment for a Supply or Service prior to the execution of this Contract.
- 4. Payments to the Vendor will be made within sixty (60) days from receipt of a detailed invoice.

#### C. Invoicing.

- 1. Final invoices from the Vendor are due no later than ninety (90) days from the Completion Date. Any invoice received past the ninety (90) day date will not be paid.
- 2. If this Contract is extended, invoices related to the extension period are due no later than ninety (90) days from the Extended Completion Date. (Quoted or Sole Source Contracts may not exceed \$24,999, including any amendments or extensions.)

#### ARTICLE IV. DEFAULT; TERMINATION; REMEDIES

#### A. Events of Default.

The following shall constitute events of default under this Contract:

- 1. The Vendor has made any material misrepresentation to the City; or
- 2. A judgment or decree is entered against the Vendor approving a petition for an arrangement, liquidation, dissolution or similar relief relating to bankruptcy or insolvency; or
- 3. The Vendor files a voluntary petition in bankruptcy or any petition or answer seeking any arrangement, liquidation or dissolution relating to bankruptcy, insolvency or other relief for debtors; or
- 4. The Vendor seeks or consents or acquiesces in the appointment of any trustee or receiver, or is the subject of any other proceeding under which a court assumes custody or control over the Vendor or of any of the Vendor's property; or
- 5. The Vendor becomes the defendant in a levy of an attachment or execution, or a debtor in an assignment for the benefit of creditors; or

- 6. The Vendor is involved in a winding up or dissolution of its corporate structure; or
- 7. Any failure by the Vendor to perform any of its obligations under this Contract, including, but not limited to, the following:
- (I) failure to commence performance of this Contract at the time specified in this Contract due to a reason or circumstance within the Vendor's reasonable control,
- (ii) failure to perform this Contract with sufficient personnel and equipment or with sufficient material to ensure the completion of this Contract within the specified time due to a reason or circumstance within the Vendor's reasonable control.
- (iii) failure to perform this Contract in a manner reasonably satisfactory to the City,
- failure to promptly re-perform within reasonable time the Services or Supplies that were properly rejected by the City as erroneous or unsatisfactory,
- (v) discontinuance of the Services or Supplies for reasons not beyond the Vendor's reasonable control,
- (vi) failure to comply with a material term of this Contract, including, but not limited to, the provision of insurance and nondiscrimination; or
- 8. Any other acts specifically and expressly stated in this Contract as constituting a basis for termination of this Contract.

#### B. Termination Upon Default.

In the event of a default by the Vendor, the City, acting through its Chief Procurement Officer, may, at its option, terminate this Contract immediately by written notice of termination. Notwithstanding the above, in the event of a default by the Vendor, the City, acting through its Chief Procurement Officer, may give notice in writing of a default, which notice shall set forth the nature of the default and shall set a date, by which the Vendor shall cure the default. If the Vendor fails to cure the default within the time as may be required by the notice, the City,

acting through its Chief Procurement Officer, may, at its option terminate the Contract.

#### C. Termination For Convenience.

- 1. Notwithstanding any language to the contrary within the body of this Contract, the City may terminate this Contract, without cause at any time, effective upon the termination date stated in the notice of termination.
- 2. If the Contract is terminated under this subsection, the Vendor shall be entitled to be paid for Supplies and/or Services delivered and accepted prior to notice of termination at the prices stated in the Contract or bid documents. Any Supplies and/or Services delivered after notification of termination but prior to the effective termination date must be approved in writing in advance by the City in order to be eligible for payment. In no event shall the Vendor be entitled to be paid for any Supplies and/or Services delivered after the effective date of termination.

#### D. Obligations Upon Termination.

Upon termination of this Contract with or without cause, the Vendor shall immediately, unless otherwise directed by the City:

- Cease performance upon the stated termination date;
- 2. Surrender to the City the Vendor's work product, which is deliverable under the Contract, whatever its state of completion; and
- 3. Return all tools, equipment, documents, correspondence, drawings, plans, models, or any other items whatsoever belonging to or supplied by the City;

#### E. Rights and Remedies.

- 1. The City shall have the right to:
  - a) disallow all or any part of the Vendor's invoices not in material compliance with this Contract; and
  - b) temporarily withhold payment pending correction by the Vendor of any deficiency; and
  - c) sue for specific performance or money damages or both, including reasonable attorneys' fees incurred in enforcing any Vendor

- obligations hereunder; and
- d) pursue remedies under any bond provided; and
- e) pursue such other local, state and federal actions and remedies as may be available to the City.
- 2. Any termination shall not effect or terminate any of the rights or remedies of the City as against the Vendor then existing, or which may accrue because of any default.
- 3. No remedy referred to in this subsection is intended to be exclusive, but shall be cumulative, and in addition to any other remedy referred to above or otherwise available to the City or Vendor at law or in equity.
- 4. The Vendor shall not gain nor assert any right, title or interest in any product produced by the Vendor under this Contract.

#### ARTICLE V. INSURANCE

The Vendor shall deposit with the City certificates of insurance issued by companies qualified to do business in the Commonwealth of Massachusetts in form and substance satisfactory to the City, with limits equal to or greater than those set forth in <a href="#">Appendix D</a> attached hereto and made a part of this Contract. Such certificates shall name the City of Somerville as an additional insured and shall contain an endorsement requiring ninety (90) calendar days written notice to the City and the City's approval prior to cancellation or change in amounts, types or scope of coverage. The Vendor shall deliver to the City new certificates of insurance at least ten (10) calendar days prior to expiration of the prior insurance and shall furnish the City with the name, business address and telephone number of the insurance agent. Vendors who are sole proprietors and who do not carry workers' compensation coverage shall certify in writing that they do not have any employees.

#### ARTICLE VI. GENERAL PROVISIONS

- A. Governing Law. This Contract shall be governed by the laws of the Commonwealth of Massachusetts.
- B. Complete Agreement. This Contract supersedes all prior agreements and understandings between the parties and may not be changed unless mutually agreed upon in writing by both parties.
- C. Condition of Enforceability Against the City. This Contract is only binding upon, and enforceable against, the City if: (1) the Contract is signed by the Mayor; (2) endorsed with approval by the City Auditor as to appropriation or availability of funds; (3) endorsed with approval by the City Solicitor as to form; and (4) funding is appropriated for this Contract or otherwise made available to the City.
- D. Taxes. Purchases incurred by the City are exempt from Federal Excise Taxes and Massachusetts Sales Tax, and prices must exclude any such taxes. Tax Exemption Certificates will be furnished upon request. The City of Somerville's Massachusetts Tax Exempt Number is: MO46 001 414.
- E. Indemnification. The Vendor agrees to take all reasonably necessary precautions to prevent injury to any persons or damage to property during the term of this Contract and shall indemnify and save the City harmless against all damages, loss or expense, including judgments, costs, attorneys' fees and interest resulting in any way, from any negligent or willful act or omission on the part of the Vendor, its agents, employees or sub-contractors or resulting directly or indirectly from the Vendor's performance under this Contract.
- **F.** Independent Contractor. The Vendor is an independent contractor and is not an employee, agent or representative of the City.
- **G. Assignment.** The Vendor shall not assign this Contract or any interest herein, without the prior written consent of the City.
- H. Sub-Contractors. The Vendor shall not engage any other company, subcontractor or individual to perform any obligation hereunder, without the prior written consent of the City.

- I. Discrimination. It is understood and agreed that it shall be a material breach of this Contract for the Vendor to engage in any practice which shall violate any provision of G.L. c. 151B, relative to discrimination in hiring, discharge, compensation or terms, conditions or privileges of employment because of race, color, religious creed, national origin, sex, sexual orientation, age, or ancestry.
- J. Severability. In the event that any paragraph or provision of this Contract shall be held to be illegal or unenforceable, such paragraph or provision shall be severed from this Contract and the entire Contract shall not fail on account thereof, but shall otherwise remain in full force and effect.
- K. Notice. The parties shall give notice in writing by one of the following methods: (I) hand-delivery; (ii) telegram; (iii) telecopier; (iv) certified mail, return receipt requested; or (v) federal express, express mail, or any other nationally recognized overnight delivery service,
