The Zoning Board of Appeals stated at their September 16, 2009 meeting that no further continuances would be granted unless this proposal begins to move through the process and be heard at the Planning Board. This proposal has been on the Planning Board agenda since November 6, 2008. There is strong community interest in this proposal and several community meetings have been held by Alderman O'Donovan and Alderman White. These meetings have been constructive. A complete redesign of the addition and several revisions to the proposal has been presented to the Planning Staff and community.

Staff agrees with the Zoning Board that the project must begin to move forward toward a final decision, but would like additional time to review this new proposal and requests a continuance until the October 22, 2009 Planning Board meeting.
