DESCRIPTION:

The present application seeks to:

1) Relocate Sector A and B antenna arrays mounted inside false chimneys that were approved as part of the Special Permit #2006-38.

FINDINGS FOR SPECIAL PERMIT MINOR REVISION

Based on the preceding, the Board recommends approval of the above-listed changes as modified by the following conditions:

1) Approval is based on plans prepared by "Dewberry-Goodkind, Inc" dated 10/25/07 and stamped into the OSPCD on December 5, 2007.

- 2) The false chimneys must be setback at least 10 feet from all edges of the roof.
- 3) The Applicant will work with the Planning Staff to ensure that the sheathing material is in harmony with the exterior brick of the building before final approval.
