<u>Legal Notice</u>: Applicant McDonald's USA, LLC and Owner Twin City Plaza LLC, seeks a special permit under the SZO §4.5.3 & §7.11.10.3 to expand the existing nonconforming fast order food establishment with a drive-up service by 324 sf as well as alter the façade and drive-thru layout that was approved by Special Permit with Site Plan Review.

I. PROJECT DESCRIPTION

1. <u>Subject Property:</u> The subject property is a 23,834 sf parcel with a 4,080 sf McDonald's restaurant located on it. The site is leased to the franchise owner, but owned in common with the Twin City Plaza. It was originally permitted with the rest of the Twin Cities Plaza, and while the McDonald's is a separate building, it operates with shared entries with the rest of the Plaza. The restaurant has a drive-thru window, and parking surrounding it. The current restaurant is a very busy site that generates significant drive-thru traffic.





2. <u>Proposal:</u> The proposal is to make improvements to the façade of the building, interior space and drive-thru layout. There will be a small addition of 292 nsf in the front of the building to accommodate the change to the interior. The changes to the façade are to update the appearance to match the new modern McDonald's design. The store will be upgraded to match the latest corporate building design including removal and covering of the mansard roof and replacing it with a new roof cap element, adding a metal awning to the front, and new storefront glazing. The traffic pattern would remain the same but circulation is expected to improve by installing an order station, a new cash booth/window and relocating the drive-thru window so that vehicles will stack more effectively. The existing operation will remain the same and the restaurant will continue to have the same number of seats, 45 employees, a 120-occupant capacity, and 24-hour operation.



3. <u>Nature of Application:</u> While fast food order establishments are allowed in the zoning ordinance, a 2007 zoning amendment prohibited new fast order food establishments with a drive-up service (SZO §7.11.10.3). Therefore, this operation became a non-conforming use at that time. Because this business was in existence prior to the zoning change, the Applicants can seek a special permit to expand the nonconforming use under SZO §4.5.3.

Furthermore, the additional square feet that the restaurant will expand requires review of parking requirements. The restaurant currently requires 33 spaces based on the gross floor area of the building (1

space per 110 gross sf) and 37 would be required with an increase in gross floor area of 324. The building and parking was permitted with the Twin City Plaza, which has a total of 631 parking spaces, 40 of which are in the McDonald's lot. A review of the most recent special permit issued at Twin City, at the time of the expansion of the supermarket, the parking chart indicates that the overall site including the Plaza and the McDonalds exceeded the overall parking requirement for the site by six (6) parking spaces. Because of this, no additional on-site parking is required. The project is expected to comply with bicycle parking requirements and therefore, four bicycle parking spaces are required for the site but not provided at this time.

The applicant must also seek a Special Permit with Site Plan Review to alter the façade and drive-thru layout that was approved by such a permit in the 1980's. The structure will continue to comply with all of the dimensional requirements. The proposal will affect the following dimensions: the ground coverage will increase from 17 to 18%, remaining below the maximum 80% coverage; the landscaped area will decrease from 21% to 20%, remaining above the 10% requirement; the floor area ratio will be 0.16, well below the 2.0 allowed; the building height will increase to 17 ft-11 in, which is below the 50 ft maximum; the right side yard from the leased area boundary would decrease from 4.6 ft to 1.4 ft and there is no required side yard setback in this district.



4. <u>Surrounding Neighborhood:</u> The surrounding area is comprised of a mix of commercial uses including the shops in the Twin City Plaza, a municipal skating rink, and auto-oriented uses along McGrath Highway. There are no immediate residential abutters to this proposal.

- 5. <u>Impacts of Proposal:</u> The addition of a small area, 324 gsf, to the nonconforming use is not anticipated to have negative impacts. The operation of the restaurant is not expanding; the number of seats and employees will not change. The purpose of the addition is to better configure the restaurant's interior space. The change to the drive-thru layout will improve the efficiency of the preexisting condition. The changes to the exterior façade will update its appearance that currently looks dated. The construction time and potential disturbance of the surrounding businesses is expected to be approximately six weeks.
- 6. <u>Green Building Practices:</u> The applicant did not indicate any green building practices on the application form.

7. Comments:

Traffic & Parking: Terry Smith reviewed the proposal and indicated that Traffic and Parking does not have any issues with it.

Fire Prevention: Has been contacted but has not yet commented on the proposal.

Ward Alderman: Has been contacted but has not yet commented on the proposal.

II. FINDINGS FOR SPECIAL PERMIT with SITE PLAN REVIEW (SZO §4.5.3 & §7.11.10.3):

In order to grant a special permit with site plan review, the SPGA must make certain findings and determinations as outlined in §5.2.5 of the SZO. This section of the report goes through §5.2.5 in detail.

This proposal for alteration to the façade and limited changes to the site plan with no change to the operation of the business does not affect the following findings:

- 1. <u>Information Supplied:</u> The Staff finds that the information provided by the Applicant conforms to the requirements of §5.2.3 of the SZO and allows for a comprehensive analysis of the project.
- 2. <u>Compliance with Standards:</u> The Applicant must comply "with such criteria or standards as may be set forth in this Ordinance which refer to the granting of the requested special permit with site plan review."

In considering a special permit under §4.5 of the SZO, Staff find that the alterations proposed would not be substantially more detrimental to the neighborhood than the existing structure and use. In judging detriment, the SPGA may consider, without limitation, impacts upon the following: traffic volumes,

traffic congestion, type of traffic, change in traffic patterns and access to the site, adequacy of municipal water supply and sewer capacity, noise, odor, glare, scale, on-street parking, shading, visual effects and neighborhood character. The addition of a small area, 324 gsf, to the nonconforming use is not anticipated to be substantially more detrimental to the neighborhood as the operation of the restaurant is not expanding; the number of seats and employees will not change. The change to the drive-thru layout is proposed to more effectively stack cars, and while the Staff does not generally support fast-food drive-thru uses, Staff understands that this proposal will improve the preexisting condition. The changes to the exterior façade will give the building an updated appearance.

The specific standards for the BA zone include locating off-street parking at the rear of the lot and providing landscaping along the primary street edge. Parking is located around the site. There is not a clear front and rear to the property given its high visibility from McGrath Highway and the driveway into the Plaza on the other side of the building. The parking space locations are not proposed to change. The landscaping is located around the perimeter and there are larger planting beds by the main pedestrian entrance of the restaurant, along McGrath Highway and at the driveway entrance. The landscaped areas are not proposed to change except that a small portion of the landscaping will be consumed by the expansion of the building.

3. <u>Purpose of District:</u> The Applicant has to ensure that the project "is consistent with the intent of the specific zoning district as specified in Article 6".

The purpose of the BA district is to, "[e]stablish and preserve business areas bordering main thoroughfares that are attractive to a wide range of uses, including retail business and services, housing, government, professional and medical offices, and places of amusement. While it is anticipated that most users will arrive by motor vehicle, it is intended that the area should be safe for and conducive to pedestrian traffic." The special permit would allow for the expansion and improvement to the façade and layout for a business that is consistent with the purpose of the BA district.

4. <u>Site and Area Compatibility:</u> The Applicant has to ensure that the project "(i)s designed in a manner that is compatible with the existing natural features of the site and is compatible with the characteristics of the surrounding area, and that the scale, massing and detailing of the buildings are compatible with those prevalent in the surrounding area".

The detailing of the building will be typical of recently updated stand-alone McDonalds. Despite the generic appearance of the building it will be an improvement to the existing out-dated design.

5. <u>Functional Design:</u> The project must meet "accepted standards and criteria for the functional design of facilities, structures, and site construction."

The proposed changes to the drive-thru including a new cash booth/window and relocating the order station is intended to improve the functional design so that vehicles will stack more effectively.

8. <u>Consistency with Purposes:</u> "Is consistent with: 1) the purposes of this Ordinance, particularly those set forth in Article 1 and Article 5; and 2) the purposes, provisions, and specific objectives applicable to the requested special permit with site plan review which may be set forth elsewhere in this Ordinance, such as, but not limited to, those at the beginning of the various sections."

The proposal is consistent with the general purposes of the Ordinance as set forth under §1.2, which includes, but is not limited to providing for and maintaining the uniquely integrated structure of uses in the City and conserving the value of land and buildings.

9. <u>Preservation of Landform and Open Space</u>: The Applicant has to ensure that "the existing land form is preserved in its natural state, insofar as practicable, by minimizing grading and the erosion or stripping of steep slopes, and by maintaining man-made features that enhance the land form, such as stone walls, with minimal alteration or disruption. In addition, all open spaces should be designed and planted to enhance the attractiveness of the neighborhood. Whenever possible, the development parcel should be laid out so that some of the landscaped areas are visible to the neighborhood."

One percent of the landscaping by the main entrance of the restaurant would be eliminated due to the expansion of the building. The Planning Staff recommends that the Applicants submit a landscape plan, that includes additional landscaping on the remainder of the site, to ensure that the quality of the open space on the site is maintained. The open space requirement will remain conforming with 10% more landscaping than is required.

19. <u>Signage:</u> The Applicant must ensure that "the size, location, design, color, texture, lighting and materials of all permanent signs and outdoor advertising structures or features shall reflect the scale and character of the proposed buildings."

The character of the structure will be that of a typical McDonalds and the signage will be consistent with this appearance. The signage will be formed acrylic faces with fluorescent illumination. The size and illumination of the signage will not be substantially different from the current signage at the site.

III. RECOMMENDATION

Special Permit with Site Plan Review under §4.5.3 & §7.11.10.3

Based on the above findings and subject to the following conditions, the Planning Staff recommends **CONDITIONAL APPROVAL** of the requested **SPECIAL PERMIT with SITE PLAN REVIEW.**
